We, the undersigned guardian(s) of _____ a minor, do hereby consent to his/her participation in programs and do forever RELEASE, acquit, discharge, and covenant to hold harmless the Town of Westport, a municipal corporation of the State of Massachusetts, and its successors, departments, officers, employees, servants, and agents, of and from any and all actions, causes of action, claims, demands, damages, costs, loss of services, expenses and compensation on account of, or in any way growing out of, directly or indirectly, all known and unknown personal injuries or property damage which well may now or hereafter have as the guardian(s) of said minor, and also all claims or right of action or damages which said minor has or hereafter may acquire, either before or after he/she has reached his/her majority resulting or to result from his/her participation in the Westport Community Schools programs. FURTHERMORE, we hereby agree to protect the Town of Westport and its successors, departments, officers, employees, servants, and agents against any claim for damages, compensation or otherwise on the part of said minor growing out of or resulting from injury to said minor in connection with his/her participation in Westport Community Schools programs, and to INDEMNIFY, reimburse or make good to the Town of Westport or its successors, departments, officers, employees, servants and agents any loss or damage or costs, including attorney's fees, the Town or its representatives may have to pay if any litigation arises from said minor's intentional grossly negligent or reckless acts or omissions while participating in said programs.
